## ON-SITE SERVICES FOUR-PHASE RE-ENTRY PLAN

<b>P H A S E  1</b>	<b>Date: Sunday, June 14, 2020</b>	<b>On-Line Service</b>	<b>10:00 a.m.</b>
	<u>On-Site/Drive Up</u> No More Than 30 Cars	<b>On-Site Service/Drive-Up</b>	<b>10:00 a.m.</b>

During Phase 1, On-Site Service/Drive-Up will be limited to 30 cars in church parking lot in designated area. A transmitter will allow those who attend church in the parking lot to tune into a radio station and listen to the service from their cars while on the premises.

You do not need to RSVP for On-Site Service/Drive Up.

We encourage your family to worship together in your car (children/youth must remain in vehicle) if in the church parking lot, or on-line at home.

We will not distribute any printed materials. Offering envelopes will be available prior to service. A common collection area for tithes and offerings (outdoors) will be available before and after service (9:45-10:00 a.m./ 10:45-11:00 a.m.).

Communion will not be provided for On-Site Service/Drive Up. We encourage you to bring Communion elements from home.

A limited amount of staff and volunteers will be available on-site, and they will be wearing masks and gloves. Common areas, including bathrooms, will not be open for use for those who attend On-Site Service/Drive-Up.

If you are a high risk because of your age or underlying health conditions, we encourage you to stay home and continue to watch on-line during Phase 1.

During Phase 2, On-Site Service/Drive-Up will be limited to 20 cars in church parking lot in designated area, and Thursday Sermon Taping/In Sanctuary will be limited to 20 people.

Thursday Sermon Taping/In Sanctuary will be for ages 12 and up. There will be no praise and worship (singing) time. There will be no childcare, children’s church classes, or youth group classes on-site. For Sunday drive-up services, we encourage your family to worship together either in your vehicles, or by bringing lawn chairs/blankets, as well as your own communion elements and remain physically distanced.

On Thursdays, entryway and sanctuary will be open from 6:45 p.m.–8:00 p.m. for sermon taping service. Use of bathrooms is strongly discouraged. All other common areas will be closed. Doors of sanctuary will be propped open. Seating in the sanctuary will be small sections and pairs to accommodate families sitting together and will be distanced 6 feet apart in accordance with the CDC guidelines. At the close of service, sections will be dismissed one-by-one. We will not distribute any printed materials. Offering envelopes will be available prior to service. A common collection area for tithes and offerings (indoors for Thursday; outdoors for Sunday) will be available to minimize risk. Communion will be provided in pre-packaged containers and placed on chairs prior to service/sermon taping to minimize passing and handling of communion elements. Communion will not be provided for Sunday Service/Drive Up.

Staff and volunteers will wear masks and gloves. All attending Thursday sermon taping must wear face masks and will be requested to have their temperature read before entering the building. Hand sanitizing stations are set up for your use indoors. If you are a high risk because of your age or underlying health conditions, we encourage you to stay home and continue to watch on-line during Phase 2.

The Sanctuary, Entryway, and Bathrooms will be sanitized according to CDC guidelines before, and after service.

During Phase 3, On-Site Service/In Sanctuary will be limited to 60 people, and On-Site Service/Drive-Up will be limited to 20 cars in church parking lot in designated area.

On-Site Service /In Sanctuary will be for ages 12 and up during Phase 2 and 3. There will be no praise and worship (singing) time. There will be no childcare, children’s church classes, or youth group classes on-site. We encourage your family to worship together in your car (children/youth must remain in vehicle) if in the church parking lot, or on-line at home.

Entryway and Sanctuary will be open from 9:45 a.m.–10:45 a.m. Use of bathrooms is strongly discouraged. Use of drinking fountain is prohibited. All other common areas will be closed. Doors of sanctuary will be propped open.

Seating in the sanctuary will be small sections and pairs to accommodate families sitting together and will be distanced 6 feet apart in accordance with the CDC guidelines.

We will not distribute any printed materials. Offering envelopes will be available prior to service. A common collection area for tithes and offerings (indoors and outdoors) will be available to minimize the risk of passing offering bags.

Communion will be provided in pre-packaged containers and placed on chairs prior to service to minimize passing and handling of communion elements. Communion will not be provided for On-Site Service/Drive Up.

At the close of service, sections will be dismissed one-by-one.

Staff and volunteers will wear masks and gloves. All attending On-Site/In Sanctuary must wear face masks and will be requested to have their temperature read before entering the building. Hand sanitizing stations are set up for your use indoors. If you are a high risk because of your age or underlying health conditions, we encourage you to stay home and continue to watch on-line during Phase 3.

The Sanctuary, Entryway, and Bathrooms will be sanitized according to CDC guidelines before, and after service.

During Phase 4, On-Site Service/In Sanctuary will have no capacity cap, and On-Site Service/Drive-Up will be limited to 10 cars in church parking lot in designated area.

Loosened social distancing in accordance with CDC guidelines. On-Site Service /In Sanctuary will reintroduce children/youth to worshipping with their families. There will be occasional praise and worship (singing) times, but *very* limited and will be announced in advance. Nurseries will be open but not staffed. Until we are all comfortable worshipping together again, children/youth will remain with their parent(s)/guardians in the Sanctuary. When it is appropriate (Date: To Be Determined), children and youth will be released to age-appropriate classes. Protocols for reuniting children/youth with their parent(s)/guardians after service is currently under review.

Use of bathrooms is strongly discouraged. Use of drinking fountain is prohibited. Doors of sanctuary and classrooms will remain open throughout the entirety of church service.

We will not distribute any printed materials. Offering envelopes will be available prior to service. A common collection area for tithes and offerings (indoors and outdoors) will be available to minimize the risk of passing offering bags.

Communion will be provided in pre-packaged containers and placed on chairs prior to service to minimize passing and handling of communion elements. Communion will not be provided for On-Site Service/Drive Up.

The Sanctuary, Entryway, and Bathrooms will be sanitized according to CDC guidelines before, and after service.
